# **Subscription Billing SOP Document Creation Updates**

1. Resolved Rounding issues on SOP document generated.


Issue was observed should the line item being invoiced have a Currency Decimal Place override of 3 or more decimal places and the line item on the contract contain a markdown to the 3<sup>rd</sup> decimal place value and the Unit price also be to the 3<sup>rd</sup> decimal place value that it resulted in the AR and Sales Distributions being rounded up incorrectly. Which this would only occur if the markdown distributions before rounding would be X.XX51 to X.XX56. This issue is now resolved.


# **Subscription Billing SOP Document Creation Updates**

2. Improved SOP Document Creation to be Compatible with Segment Override.


This is an update to the Subscription Billing SOP document creation process to make it compatible with the GP Segment Override value which is set on the GP Site ID. Should the Site ID set on the line item have an Account Segment ID override set then when the SOP document is created the distribution accounts will be overridden for that segment change if an account for that segment change exists. If such an account does not exist, then it will retain the original account value. For example, should the sales account be set to 777-7777-03 and the site ID override is for the first segment and set to the value 888 then when the SOP document is created it will use the sales account 888-7777-03 if this account exists. If it does not, then the sales account will remain as 777-7777-03.











#### 3. Markdown Deferral has incorrect Billing recognition Account.

Issue observed with Line Deferrals and for Deferral Setup of Balance Sheet. Should line item have Markdown that was set to be deferred then the Deferral setup on the SOP transaction was setting the incorrect recognition account on the distribution row. This issue is now resolved.

#### 4. Next Pay Date set incorrectly on Contract Line for Payment processing.

This issue only occurred for Subscription Billing Contract lines that were created and not flagged for Payment processing. Should the user generate the SOP document the creation process was advancing the Next Pay Date for the contract line still based on the Default date 01/01/1900 and the billing frequency. This issue is now resolved so that next paydate will not advance in the back-end table during sop document creation unless the feature is enabled. Should users enable the payment processing for existing lines that were already invoiced it will default the next paydate accordingly.

## **Subscription Billing Contract Entry Updates**

#### 1. Auto Deselect for Prime Consolidated line items.

Trigger is added to Subscription Billing Contract Entry when Save is selected. This trigger will automatically deselect all line items flagged as Prime if the Contract header has the Enable Line Consolidation option unchecked. Issues were noticed causing rollback to fail on any line item flagged as Prime line item when line consolidation is not turned on for the Contract on the Contract Header. A secondary issue occurs during SOP document creation that the line item flagged as Prime fails



to have line deferral settings set should it be flagged for line deferrals. To overcome this issue the trigger was added during save to force all lines to not be flagged as prime.

This will not resolve any pre-existing contract lines. To resolve pre-existing data it is recommended to run the following SQL statements:

#### **Subscription Billing Payment Processing**

1. New EFT Payment Processing for Subscription Billing Contract Line items. We have added a new EFT payment processing add on the Subscription Billing which allows the user to setup a semi-automated payment plan per line item on a contract. With this feature you can invoice users on a specified billing frequency and process payments on that line item at a different frequency. For example, you can invoice annually but process monthly payments for the line item.

With this build you will be able to.

- I. Set the initial setup for Payment processing on line items.
- II. Generate the SOP Invoices which will include any down payments if a down payment was specified in the payment plan.
- III. Review and / or update the payment plan for the SOP document created.
- IV. Process Generating payments based on the payment plans set on invoices created.

This update detailed below is for the following sections.



#### **Subscription Billing Contract Entry**



1. In Contract Entry on the line items tab select the line you wish to setup payment Processing for. Then select the zoom into next to Ext Price.

This will open the Item payment Processing Setup for the line item. From here you will be specifying the setup for Payment processing for the line item.



2. To enable Payment Processing check the Payment Processing Checkbox

This will enable the fields.

- a. Down Payment used to specify an initial down payment to be included on the SOP invoice being generated. This defaults as \$0.00 but can be specified if needed.
- b. **Payment Frequency** This defaults to Monthly for every contract line item but can be set to




- Weekly
- Bimonthly
- Quarterly
- Semi-annually
- Annually
- One Time
- c. **Number of Payments** this will default to be calculated based on the Payment Frequency and Billing Frequency. You can override the number of payments.


Note adjusting the Payment frequency amount and / or Number of payments will auto recalculate the Frequency Amount. If Manual Calculation is checked then changing these values will force the checkbox unchecked.

- d. Manual Calculation Checkbox Check this box if you wish to override the calculated frequency amount. The calculated frequency amount is based on the Line total which will include estimate tax amounts should tax be calculated on the line item. Once checked this will enable the Frequency Amount field. Note the final payment will be the amount remaining regardless of frequency amount specified.
- e. **Start Payment Date** This will default to be the same date as the next bill date. Once the Contract is picked up for invoicing this date will advance on the contract based on the Billing Frequency similar to that of the Next Bill date.










3. Once you completed select OK this will return you back to Contract Entry on the Line details. You will notice a flag next to the Extended Price for that line. This is a visual indicator that a payment plan was setup on the line item. Once you save the contract it will complete the setup for the line items.






#### **SOP Document Creation.**


The workflow for this process has not changed. You can still use either Instant create from the Contract Entry window or the Subscription Billing Create SOP documents window to generate the invoices on a mass scale.

The only change with SOP Document creation is that when the SOP invoice is created if any of the line items had a down payment set on it then it will create the EFT payment directly on the SOP invoice generated only for the down payment amount.

The example below is based on the Contract example above where it had 2 line items one with a down payment for \$100.00 and the other for \$50.00 as such a \$150.00 payment was created directly on the SOP invoice.







#### **SOP Item Payment Processing Maintenance.**

This is the actual payment processing for the SOP invoice line item. This is accessible through the Subscription Billing Document History window. Which is accessible form the Inquiry pane or by selecting the Document History button in Contract Entry.

From this window you would select the row for the SOP invoice generated and then press

the Document Amount link ( Document Amount )

This will open the Document History line details. Similar to Contract Entry if the line item has payment processing setup it will have a flag, , in the extended price field.

You can zoom into the Item Payment Processing Maintenance for that line item by selecting the line item row and pressing the zoom into arrow

This window will contain the payment processing details from the SOP Contract Line item after the SOP invoice has been created. Should you need to make changes to the setup you can.

The changes that can be made are


1. Inactive Checkbox – This allows you to turn off payment processing for this line once checked the Inactive Reason field will be enabled allowing you to enter a reason you



- wish to inactivate the payment plane. Once example would be if the Invoice was returned.
- 2. Payment Frequency This will determine the frequency the payments will be generated for.
- 3. Number of Payments this will determine how many payments you wish to generate for this item.
- 4. Manual Calculation similar to Contract entry if you wish to override the calculated frequency amount you would check this option which enables the frequency amount field so you can set the amount for each payment. Note that the final payment being generated will use the estimated final pay amount.
- 5. Adjustment Amount this is used in case you need to make a short term adjustment for the next payment.
- 6. Number of Adjustments this is used to specify how many times this adjustment will be applied. It will reduce after each payment processed.
- 7. Next Payment Date. This is used to determine the document date for the next payment being generated. It will advance based on the payment frequency after each payment is generated.

The following fields are informational only for the window.

- 1. Next Payment amount This is the frequency amount plus any adjustment amount.
- 2. Num of pay less Received. This will be the number of payments remaining.
- 3. Estimated Final Pay Date. This is the date for the final payment.
- 4. Estimated Final Pay Amount. This is the estimated final payment amount based on the number of payments remaining and the amount remaining.





#### **Subscription Billing Cash Receipt Generator**

This is the generator you will need to run to generate the payments for each payment period.

It is accessible form the Transactions pane of the Subscription Billing menu.

The required fields are Batch id and payments due on or before date.


The payments due on or before date field is basically the next payment date you wish to create for. The generator will then generate the payments for all sop line items that have a payment plan setup with a payment remaining and a next payment date of this date or prior.

You can use optional filters for Contract Class and Contract Number as well as Item Number range filter.

Once the values are set press the Generate button to create the payment(s)

This will generate a single EFT payment for each customer ID and apply it accordingly to the SOP invoices.


You will receive a report indicating what was generated and applied to based on the item number that had a payment plan.

#### **Subscription Billing Importer Updates**

For the importer we have updated the fields available for New Contract Line and Update Contract Line item import options as well created a new Import Option to update the SOP document history for existing SOP documents to setup and modify the payment plans being processed.

#### **Contract Line Items and Update Contract Line Import.**

For these two Import options the additional fields have been added to be able to set the Contract line-item payment processing setup. These fields are detailed below.



		Should this field be mapped the date format set on the mapped line MUST be the same date format in the file.
Payment Number Of	Integer	This is an optional field. By default, the Number of payments will be calculated based on the Payment Frequency set for the line item and the Billing Period duration for the line item. For Example, if the Line item is an Annual Frequency for Billing but the Payment Frequency is Monthly then this will default to 12.
Payment Down Payment	Currency	This field is optional. It is to allow the user to import a specified Down payment amount for the line item which will be the payment made directly on the SOP transaction during the Create SOP documents process. For example, should the line item be for an extended price for \$1300.00 with a billing frequency of Annual and the payment plan is setup for monthly you can specify an initial down payment of \$100.00 which will be the payment created directly on the SOP invoice when the SOP document is created. This leaves \$1200.00 which will be created each payment period which if the payment frequency is monthly will be each month.





#### **Update Line Payment Process Import**

This is the new Import option which will allow you to update your existing SOP transaction payment plans.

This will be a new Contract File Type called Update Line Payment Process in the Subscription Billing Importer. These fields that are available are listed below. For this import you will need to know the SOP line-item Sequence. As such its recommended to create a new Smartlist object using the newly created view SB\_LinePaymentProcessingActive

Contract Number	String	This is the Contract Number associated to the sop document. This is an optional field for the import.
SOP Number	String	Required Field for the import. This will associate the exact SOP document you require to create the payment plan for.
SOP Type	Integer	This is a required field and should only contain Invoice Type
SOP Line Item Sequence	Numeric	This is a required field so you can associate the payment plan with the exact SOP line-item number.



Payment Manual Calculation	Integer	This field is optional and only required if you wish override the calculated frequency Amount.  0 = Unchecked  1 = Checked
Payment Frequency Amount	Currency	This is optional field and not required. By Default, this will be calculated for the user based on the Ext price for the line + Calculated Tax amount which is estimated based on the tax set for the SOP line item. It also takes into consideration the Payment Frequency and number of payments.  Should this field be mapped as part of the import then the Payment Manual Calculation is a required field
Payment Next- Payment Date	Date	This field is optional as will be the Start Payment Date for the line item. By default, the Next Payment Date will default to be the same value as the Next Bill date for the line item.



		Should this field be mapped the date format set on the mapped line MUST be the same date format in the file.
Payment Number Of	Integer	This is an optional field. By default, the Number of payments will be calculated based on the Payment Frequency set for the line item and the Billing Period duration for the line item. For Example, if the Line item is an Annual Frequency for Billing but the Payment Frequency is Monthly then this will default to 12.
Payment Down Payment	Currency	This field is optional. It is to allow the user to import a specified Down payment amount for the line item which will be the payment made directly on the SOP transaction during the Create SOP documents process. For example, should the line item be for an extended price for \$1300.00 with a billing frequency of Annual and the payment plan is setup for monthly you can specify an initial down payment of \$100.00 which will be the payment created directly on the SOP invoice when the SOP document is created. This leaves \$1200.00 which will be created each payment period which if the payment frequency is monthly will be each month.





#### **Reporting Views**


A new view is created per company Db called SB\_LinePaymentProcessingActive, which can be used to create a new Smartlist object. This view details the line-item document history and would contain the SOP Line-Item Sequence Number that can be used as part of the Update Line Payment Process import.

## **Subscription Billing Contract Entry Updates**

#### 1. Improved Validation for invoiced Line items.

Validation updated preventing users from changing the line item on a contract when it has been picked up for SOP document creation. This validation would prevent users from changing the item card being used after invoicing occurs.





## **Subscription Billing Copy Contract Updates**

1. Resolved issues with Contract Note being copied incorrectly.

Issue observed should Contract contain a Contract Note on the header and that contract is copied to another contract it will copy the note index used on that contract to the Target Contract. Which in effect all the contracts the source was copied to are now linked to the same note index. To resolve this issue contract notes will not be copied to the target Contract.

#### **Subscription Billing SOP Document Creation Updates**

1. Updated EFT Active Validation during SOP document Creation.

EFT validation added during SOP document Creation and Payment Document Creation to occur should customer card no longer be set for EFT and payment processing on the Contract / SOP document be setup. This validation added to account for scenarios where EFT has been removed from the customer card after the payment plan was setup.

2. Resolved issues with Sales\_PP\_Offset\_Sequence and MARK\_PP\_Offset\_Sequence being set incorrectly.

This issue was observed when using Deferral Profile Groups on a contract which resulted in the incorrect Seq numbers being set for the line items in Subscription Billing Document History. This resulted in Errors being observed in the SB – Deferral SmartList object showing incorrect values. This issue is now resolved for future invoicing.

3. Fixed Rounding issues for SOP distributions on SOP document generated.

Problem observed should SB Contract Line item have a fraction of penny rounding occur on the line item that we are failing to pass the incorrect rounding to the SOP invoice generated. This resulted in distribution errors when saving and posting of the document. This issue is now resolved.

4. New Validation for Site ID for line item.

Validation added preventing the SOP document from being generated for inventory line items should the line item not be assigned the Site ID set on the line item.



#### **Subscription Billing Importer Updates**

Resolved issues with rounding occurring during line-item import.
 Issue observed where line items being imported could cause a rounding issue to occur for the Extended price amount. This issue is now resolved.

Note that this fix is not pro-active and will not resolve any pre-existing data issues. Users will need to run SQL updates to resolve pre-existing data issues.


#### **Subscription Billing SOP Document Creation updates**

1. Improved Distributions on SOP document Created.

On SOP Invoices generated through Subscription Billing it will now set a separate distribution row for Sales (and Markdown if markdown set) for each line item being invoiced from the Contract. These will be separate distribution rows even if the line items are being distributed to the same sales / Markdown Account. This improvement was added to accommodate limitations with negative extended price line items on Contracts failing to be deferred. Negative Extended price line items will now appear as a Debit row instead of being part of a balanced Credit distribution row.

This update will also be distributed this method if Line Consolidated is used. Line Consolidation will no longer have additional OTHER distribution rows.





#### Subscription Billing SmartList updates

1. Fixed problem with Contract Detailed Smartlist object permissions issues. Problem noticed that user would receive a failed permissions issue when accessing the Contract Detailed Smartlist object. Issue caused because permissions failed to be set on the stored procedures for the Smartlist object. Note that this update will only prevent the error from occurring if the user did not have the Smartlist object previously. It is not retro-active to fix existing stored procedures that are missing the permissions. 

In this case the validation would indicate that the project remaining is less than the extended price. This validation error is now resolved.



1. New User Preference option to disable the auto tab sequence. Users can now disable the auto tab sequence in Contract Entry when adding additional line items to a contract. Out of the box this feature is enabled for all users. Which it will automatically tab to the end date field after entering in a second line item on a contract. Users can choose to manually disable it for their own user ID in the User Preferences window.


















## **Subscription Billing Copy Contract Updates**


1. Resolved issues with Customer Name being overwritten on Target Contracts. Issue observed where Target Contract had its Customer Name value overwritten on the Contract Header when using the Copy Contract Feature. This is now resolved. Please note that this update will also resolve any pre-exiting data issues with the Customer Name being incorrect on the Contract Header during Table Conversion process when the build is installed.

#### **Deferral Profile Group Updates**

1. New Trigger to remove Profile from Deferral Profile groups when Profile is deleted.

New Trigger added to the product to remove the Deferral Profile from Deferral Profile Groups when the Profile is deleted from the Deferral Profile window. Previously this would not remove the profile in the Deferral Profile Group which caused errors during SOP document creation. Note that this will not resolve any pre-existing data issues should your Deferral Profile Group contain Profiles that no longer exist. You will need to manually remove these by right clicking on the Profile in the group window and select Delete row. These will be noticeable as these would be profiles without a deferral Account shown when reviewing in the Deferral Profile Group Maintenance window.



1. Improved Subscription Billing Smartlist to display the correct Currency Symbol on Amount fields.

Initially all amount fields would show the Functional Currency Symbol for any amount fields. The Smartlist objects will now display the currency Symbol associated to the Currency ID set for the Contract.






2. New Fields for SB - Contract Detailed SmartList Object.

# **Subscription Billing SOP Document Creation Updates**

1. Issue observed with Contract Still consolidating Line items even though Option is disabled on Contract Header.

Problem observed that should user have created Contract with initially having Line Consolidated feature enabled on the Contract Header when the new line items were added to the Contract and then disabled the feature on the Contract Header then the line items on the contract would still be Consolidated if they had a Consolidate Line Group set on them. This issue is now resolved that should the Contract Header have this feature not enabled that it will not Consolidate any line items on the contract during SOP Document creation even if they have a group set.

2. Validation for Deferral Profile not set for SOP Module is now disabled. This validation was originally in SOP document creation to prevent SOP invoices from being generated should the Contract have a deferral Profile Group that contained a Deferral Profile that was not set for the SOP Module. Issues were observed when the Profile was set for the SOP module and Receivables and / or Invoicing modules. This caused the Validation to believe the profile was not set for the SOP module because the profile was set for multiple transaction types. To overcome this issue the Validation was removed during SOP Document Creation.



Improved expire validation on Subscription Billing Contract Entry
We have updated the validation that occurs when a user sets the end date on a line
item to be prior to the next bill date. Previously a user would receive a notification
informing them that end date must be on or after next build date. It will now



acknowledge that your intention was to expire the line item. And give you the option to expire the line item.



### 2. Improved Consolidated line item options.

We have updated Consolidated Line item enhancement to ensure that the Prime Consolidated Line checkbox and Consolidated Line Group Field are locked from editing on a contract when the feature is turned off in Subscription Billing Setup. Previously these fields would still be enabled if the Contract Header had the option enabled for consolidated line items.

# **Resolved Issues**

Issue observed with Subscription Billing importer kicking off Project Price CB validation when importing new line items when importing a new project price and the project Price check box was set as a constant value. This has been corrected to identify when the project price checkbox is set as a constant for the importer.

2. Resolved issues with validation check during SOP doc creation for consolidated line items.

Issues were uncovered that if Contract was created and initially set to allow consolidated line items and new line items were added but user later turned off consolidated line items in Subscription Billing setup it caused the validation to occur. This has been fixed.

3. Resolved issues with Subscription Billing Importer Comment Text.

Issue noticed that should user import line item comment text using Subscription Billing importer it was causing the Text vailing to be parsed on ME50417 table to the proper Comment \_1, Comment\_2, Comment\_3, Comment\_4 columns. This resulted in reporting issues when the SOP invoice was generated, and invoice was printed. This issue is now resolved to ensure any new line items imported in are correctly parsed.



4. Resolved issues with Comment Text failing to be deleted from ME50417 table when Contract is deleted.

Problem observed that if Contract had line items with Comment text when the contract was deleted the comment text in ME50417 table failed to be deleted. This resulted in orphaned records. This is now resolved.

### **Enhancements**

 Improved validation check for SOP document creation to confirm that Nodus is setup.

We have improved the validation checking if Nodus CC Advantage is installed when creating SOP Document by not only checking that it is installed but also that it is Set up for Nodus has been completed. This is done by checking the MS273532 table for records.

Issue observed with Subscription Billing Consolidated Line items where it failed to insert the parent line item into the consolidated line details table ME50413C when this line item is not deferred. This issue is now resolved.

2. Fixed problem with Contract header synchronization with Contract Status flip to expired / inactive.

Problem observed that should user adjust the contract status to expired it failed to synchronize the end date on the contract header with the end date updates that occur for the active line items. This is now resolved.


3. Resolved issue with Duplicate deferral entries shown in the SB Deferral smartlist objects.

Issue observed that should contract contain consolidated line items but also have line items that were not consolidated, and all lines were being deferred resulted in duplicate entries being displayed in the Smartlist object. # 5. Resolved issue with Price Level defaulting on Contract Entry with Customer Defaults.

Problem observed with line item price level defaulting. Should Customer Card be set with default price level and user added line item to contract for that customer id where the price level did not exist on the item card the user would get the validation error Currency / Price Level / U of M Combination. This has been resolved. With the code change should the Price level not exist then the price level will default using the Item cards default price level if it exists. If it does not, then use will receive the appropriate validation message.

# 6. Fixed Subscription Billing checklinks issues.

The following problems were observed when running Subscription Billing Checklinks:

# a. Contract Header Status Flip incorrect and Line item update for One time billing frequencies.

in this case the Contract is set to Active or Expired and only has a line item on it with a one time billing frequency that was billed already but re-activated for future one time billings. (Note this is done by un-checking the inactive Checkbox which then removes the last billed date for the line item to reactivate it for future billing)

### b. Contract Header Status Flip incorrect to Active Status.

In this case the Contract Header is Expired already, and all the line items are flagged as Inactive on the Contract but one line item does not have an end date. Currently you can have a contract status as Expired and there is a line item flagged as inactive without an end date. When checklinks is run its assuming that this line item is not expired so its forcing the Contract header to be flipped to active.

Both issues are now resolved with Subscription Billing Checklinks.

# 7. Fixed Multicurrency compatibility issues for Line consolidate line history.



Problem observed that Consolidated line items failed to set correct functional amounts in ME5013C table when contract is for a foreign currency. This issue is now resolved.



This update added for future updates on the Detail Edit report to be able to display the billing cycle for line items. Note this update currently will not account for prorated billing periods. That will be updated in future updates.
- Improved performance of Contract Detailed Smartlist object.

- 3. Improved Document History window to show the amount remaining for the SOP invoice.

This update is a new Amount Remaining Column for the Subscription Billing Document History window. This will allow you to review the details of the payments that were applied to the SOP invoice or the Invoices the Return was applied to.








# 4. New Contract Numbering setup by Customer ID Option with select Customer ID first.

This update is an optional setting in Subscription Billing Setup. It allows you to set the next Contract number based on the Customer ID – Suffix numbering. The system will auto increment to the next available suffix number based on the Customer ID selected. By default, the suffix numbering set is -001. However, this can be adjusted by the user.

Once enabled in Subscription Billing setup then when a user starts a new contract it will open the Customer ID field allowing them to select the Customer ID first. Once the Customer ID is selected it will default the next available Contract Number based on customer ID + next available Suffix. For example, if Customer ID is ANDES001 then the next contract number will be ANDES001-001.

With this feature enabled a secondary option for Contract Lookup is available. This secondary option is to filter contracts in the lookup by Customer ID.

New option available for users in the Copy Contract option to be able to include inactive checked items. They can also enable a secondary option to uncheck the inactive Checkbox when the line item is copied to the target contract.



Contract status failed to take into consideration "and ME Billing End Date <> '01/01/1900'". This issue is now resolved.



# 2. Fixed problem with Table conversion resulting in cannot insert Null value into ME50405 table.

This issue only occurs if upgrading from an older GP2013 or earlier version of Subscription Billing that did not have the User Defined Number of Days/Months column on the Contract Header. This issue is now resolved.

# 3. Resolved problem with Kit items failing to calculate the Ext Price in Contract Entry.

This issue is a visual issue that occurred in Contract Entry only. The SOP document would still create with the proper Ext price listed for the Kit line item. This issue is resolved.

### 4. Fixed issues with Smartlist object Search for any Date fields.

Problem observed when running Search for any Date field on the following Smartlist Objects:




# 1. Resolved issues with Deleting Deferrals generated by Delayed Revenue Recognition.

Issue observed that if a contract line item was flagged for delayed revenue recognition and the user has generated the deferrals using the Delayed Revenue Recognition process should the deferral be deleted prior to posting it would cause invalid date SQL error to occur when accessing the contract. This issue is now resolved. Should the deferral generated be deleted instead of posted the error will no longer occur and the following updates will occur on the Contract.

- a. The Contract Line item details will be reverted to indicate that the revenue is still not recognized as such you can re-create the deferrals for the line item in the Delayed Revenue Recognition window.
- b. Document history will also now be removed for the deferral entry that was deleted. Previously this was not being removed from document history.

### 2. Fixed issues with SOP document creation with Nodus Credit Card.

Issue noticed that if the Contracts Nodus CC id did not have an expiration date set then it would result in a SQL error to occur during SOP document creation for that contract. This issue is now resolved. Should a Contract have a Nodus Credit Card ID set without an expiration date on the contract this will result in a validation warning that the Nodus Credit Card expiry date is missing. Users can still proceed with the SOP document creation, but no payment will be applied to the document as well Nodus Batch Verify process will fail for this transaction for the same error that there is no expiration date.



### 3. Resolved issues with Table Conversion.

Two issues were observed with table conversion if you upgraded from an older version of Subscription Billing that did not have the new column on ME50403 NEWLNITMSEQ.

- The first issue is users would receive a SQL error for Improve2-PreTableConversionSpecialUpdates
- The second issue is users would receive a SQL error could not insert duplicate row into ME\_Batch\_Invoice\_MSTR\_DTL table. This was caused by the unique index update on the previous Build release for NEWLNITMSEQ.

The issues are now resolved. Pretable conversion updates will be skipped if column does not exist in the table. The column NEWLNITMSEQ is also reverted to no longer being a unique index field which will be re-visited in future review.

Should you upgrade to this latest build from the previous build release listed below the unique index field update will not occur. You should not need this to be changed if you did not upgrade to the previous build first from an older version of GP. If



This is now resolved and the sort order for the Consolidated line details will

Problem observed that should user import in a new line item with a Next Bill Date and End date being the same date and did not import the start date value that they would receive a validation message indicating that the start date must be on or before the End date. 



Issue observed when Contract had Multiple Line Consolidation groups and each Group contained a Primary Line item with the same distribution Accounts. This resulted in the second groups primary line item distribution failing to be added to the SOP document. This issue is now resolved, and all lines will be properly distributed on the SOP document.

- 2. Resolved issue with zoom into option on item Search window.

  Problem observed that when item is selected in Item Search window it failed to set focus on that item in Subscription Billing Contract Entry. This issue is now resolved.
- 3. Fixed problem with date search not returning any results
  Problem observed that if you did a search on any date field no results would return
  for the following SmartList objects:
  - SB Contract Detailed
  - SB Archive Contract Header
  - SB Contract Header
- 4. Fixed Issue with mystery line items appearing on the Line items tab.

Issue noticed that if the user changed the Ship to Address id, Salesperson iD, or Sales Territory field on the contract header and is prompted to roll down changes to the Contract Line items that if they went to the line items tab it would display additional line items from other contracts in the front-end UI only. This issue required that multiple users be editing contracts at the same time. And was caused because Contract Entry was not filtering out line items for different Contracts in the ME50403TEMP table. This issue is now resolved.

5. Resolved problem with Line item consolidation missing prime line item deferrals.

Problem observed when Consolidated line item group contained at least 3-line items and one child line item that was purposely not flagged for deferral but all other line



items including prime line item were. In this case the child line items flagged for deferral were being deferred but the prime line item failed to have deferrals set. This issue is now resolved.

# 6. Fixed issue with Subscription Billing Line Item Defaults receiving unexpected error.

Issue noticed that should user make change to an existing Subscription Billing Line item default and is prompted to save when looking up another Line item and selects save they would receive unexpected error message. This issue is now resolved.

# 7. Resolved issue with SOP Document Creation failing to transfer Comment Text to SOP document.

Issue observed that if Contract line item had Line Comment ID set that when the SOP document was created the Text associated to the Comment ID failed to be set on the SOP document Created. This issue only occurred if the Comment Text was not edited on the Contract. This issue is now resolved.

# 8. Fixed problem observed with Previous and Next VCR buttons on Subscription Billing Contract Entry.

Problem observed if the user was on the first Contract and selected the Previous VCR button or were on the last Contract and selected the Next VCR button. Should these VCR buttons be selected, and the user then selected any line item on the Line item tab in Subscription Billing Contract Entry they would receive a notification that the line item was deleted by another user. Should the user save the contract then the line item would have been deleted. This issue is now resolved.









The service date will still advance correctly based on the frequency of the line item regardless of the number of periods specified for the line item. Changing the frequency of the line item will reset the Number of periods specified for the line item back to default as well as deselecting defer revenue or selecting delay recognition.

Proration of service periods is not compatible with changing the Number of Periods as the user has made a logical choice to specify the number of periods for recognition.




This new feature is compatible with Line item Consolidation and should you require to generate a return document from a posted transaction that had the service period overwritten by the Number of periods the return document would retain the originating service start and end date used as part of the override.

As this is a new field in Contract Entry any integration into Subscription Billing would need to be updated. The new column is NUMOFPER in ME50403 added at the end of the table. 

### **Resolved Issues**

 Resolved issues with COPY contract failing to set the correct NEWLNITMSEQ number for line items copied to the Target Contract.

Issue observed when using the copy contract to copy line items to an existing contract that had pre-existing line items that also had its order changed so that the last line item displayed on the contract no longer had the highest NEWLNITMSEQ in the line items table. The result is that if you copied new line items to this contract that the first line item copied over would have the same NEWLNITMSEQ as an existing line item. This resulted in document creation errors. This issue is now resolved.

2. Resolved problem with Service period displayed incorrectly for line items with One-Time billing frequency.



This is now resolved so that End of the service period will be the same date as the service date for the line item.

# 3. Fixed SQL error occurring when prompted to save contract.

Errors observed when the user is prompted to save the contract when leaving the contract after not saving changes. Users would receive one of the following errors when selecting save on the prompt to save.

- Error in executing SQL script 1-Get\_record\_number
- Error in executing SQL script 2-Get\_Record\_Number

This error is now resolved.

# 4. Resolved issue with Subscription Billing Importer for Document ID label. Issue observed where field label for Document ID was shown as "\t ID" for the Contract Header and Update Contract Header Import type. This is now resolved so field displays the proper value Document ID.

# 5. Fixed issues with Comment text appearing for Line comment on Line item where not Comment text was set on the Contract.

Issue was observed that a comment text was appearing on the comment text for the line item in SOP Transaction entry when no Comment Text was set on the line item in the Contract. This issue occurred because there was a blank comment ID in the SY04200 table with Comment Text associated to it. To resolve the problem Document Creation will ignore any Comment text associated to a blank Comment ID.

# 6. Resolved problem with Unhandled exception error when deleting Child contract from Parent Contract Relationship window.

Problem observed when attempting to remove a child contract from the parent Child relationship in the Parent Contract Relationship window when Contract entry window was not open. Users would receive error:

"Unhandled script exception:

Illegal addres for field 'SQLConnection in script

'DoesParentContractHaveUnPostedDocuments'. Script terminated"
This issue is now resolved so Parent Contract Relationship Window creates its own SQL connection.

# 7. Resolved issues with Table conversion on sequence of Events that occurred. Issue observed when upgrading Subscription Billing from GP2013 or older to GP2015 and higher and including checklinks as part of initial table conversion. This resulted in Subscription Billing document history to be removed for posted and Transferred SOP documents because checklinks had been run prior to special script updates to set the Posted and Transferred flag values on pre-existing document history. Checklinks had been previously updated to check for orphaned Subscription Billing Document history and as a result it believed this document history was from orphaned records as the posted flag was not set yet. The order of events fixed to ensure that checklinks is processed after special updates.

# 8. Fixed Problem with missing consolidated line details when creating SOP return document.

Problem observed where Consolidated line details were missing when generating SOP return document from posted invoice. The missing details were missing from the User Interface when zooming into the Consolidated line details. This issue was



caused if the Consolidated line items on the Contract had a non-consolidated line item or line item in a different consolidation group between the line items in the group which resulted in incorrect LNITMSEQ on the child line item in ME50413C table to have incorrect value. This issue is now resolved for any new SOP documents being generated.

9. Resolved issues with Markdown Line deferrals on Child Consolidated Line items for Profit and Loss Deferrals.

Issue observed that Child line item distributions had incorrect Markdown Deferred Billing and Markdown Billing Recognition account used for the deferral set in Deferral Entry. The accounts that were used were from the Parent Line item. This issue is now resolved.



## **Enhancements**

  - With recent update users can now have consolidated line items across multiple contracts with Contract Consolidation. As such validation was added to prevent document from being generated if multiple Contracts in the Contract consolidation group have line items flagged as the primary line item in the consolidation group as there can only be one primary ling item in a consolidated group.





2. Fixed problem with Line Deferrals for Profit and Loss Deferrals setup. Obscure issue observed when Subscription Billing setup was set to have Line Consolidation enabled but Contract was set to not have Consolidated line items but the line items on the contract were added and had a consolidation group set before Line consolidation was turned off on the Contract Header. The issue also required that the original Primary line item was flagged for delayed recognition and both line items would need to have the same distribution accounts. When the SOP document was generated the initial other distribution for delayed recognition for profit and loss deferral was being set with the incorrect amount. This is now resolved.
